ORDER


Sub: Regulation of the Status of AAO/AO/Sr.AOs' of DOP currently on deputation to DOT on the amalgamation of IP&TAFS Gr.'B' w.e.f. from 1.09.2009.

Consequent upon the amalgamation of IP&T AFS Gr.B cadre of Postal and Telecom stream w.e.f.1.9.2009 vide Gazette Notification no.2198 (E) dated 28th August 2009, the status of AAOs and A.O/Sr.A.Os of Department of Posts working on deputation basis in Department of Telecommunications needs to be regulated. Accordingly, it is ordered as under:

- (i) The deputation status of all IP&T AFS Gr.'B' Officers of Postal stream is treated as **deemed to have come to an end on 31.8.2009 Afternoon.**
- (ii) All regular officers working in the respective grade may be retained in the same grade on as is where is basis from 1.9.2009
- (iii) Those Officers who were not regular in the substantive grade and working in next higher grade in the deputation post **will be retained** on local officiating on purely temporary basis in the same grade for a period of 180 days or till regular incumbents are posted whichever is earlier.
- (iv) The local officiating promotion does not confer any right to regular promotion from 1.9.2009 and will not count for seniority in the grade for any purpose.
- (v) Pr.CCAs/CCAs will send the list of Officers currently on deputation and covered in (I to iv above) for confirmation and records.
- (vi) Necessary charge reports may be obtained and two copies may be sent to the undersigned for records.

None of the Officers should be relieved from their current Headquarters without the specific approval of this office.


